 - Focus on innovative/new technology/new case studies
- ✓ Good Average Rating of 4.0 and above
- ✓ Geographical Diversity
- ✓ Organisational Diversity (Sessions should have a fair distribution between NOC, IOC, Service and Academia)
- ✓ No Commercialism

Guidelines for Session Co-Chairpersons

Responsibilities Prior to the Conference:

- Contact authors periodically to ensure that the Manuscript deadline is met.
- Contact authors to ensure their attendance at the conference.

- Develop discussion questions for the session.

- Introduce speakers.
